III. STATUS OF PARTICIPANTS

5. The Governments of Argentina, Brazil and Paraguay will take the necessary steps to facilitate the arrival and departure of participants invited by the Organization, as well as their stay. Throughout their stay, participants will enjoy the privileges and immunities provided for in the Agreement between the Organization and the Governments of these three countries in conformity to Article No. 32 of the WTO Statutes.

IV. FRONTIER FORMALITIES AND LAISSEZ-PASSER

a) Argentina

- 6. Participants should take note of the conditions of entry into Argentinean territory, which are as follows:

b) Brazil

- 8. Participants should take note of the conditions of entry into Brazilian territory, which are as follows:
- A. For nationals of the countries listed below, no visa is required for stays not exceeding 90 days:

Argentina, Austria, Bahamas, Barbados, Belgium, Bolivia, Chile, Colombia, Costa Rica, Denmark, Ecuador, Finland, France, Hungary, Germany, Greece, Holy See, Iceland, Ireland, Italy, Liechtenstein, Luxembourg, Mexico, Morocco, Monaco, Namibia, Netherlands, Norway, Panama, Paraguay, Peru, Philippines, Poland, Portugal, Republic of Korea, San Marino, Slovenia, South Africa, Spain, Suriname, Sweden, Switzerland, Thailand, Trinidad and Tobago, Turkey, United Kingdom, Uruguay and Venezuela;

B. For nationals of the countries listed below, an entry visa is required:

C. For nationals of the countries listed below, no visa is required for holders of a diplomatic or official passport:

Argentina, Austria, Belgium, Colombia, Ecuador, Germany, Greece, Israel, Italy, Luxembourg, Norway, Paraguay, Peru, Portugal, Spain, Sweden, Switzerland, Tunisia and Uruguay;

- D. For nationals of El Salvador, no visa is required for holders of a diplomatic or official passport for stays not exceeding 90 days.
- 9. Participants should note that it is necessary to have a return ticket to their country of origin.
- 10. Where necessary, delegates are requested to contact the diplomatic or consular missions of Argentina and Brazil in their countries in order to obtain entry visas for these countries.
- 11. Delegates in whose countries Argentina and Brazil have no diplomatic mission are requested to contact the Secretariat of the Organization sufficiently in advance, providing all the information that will enable the correspondent authorities to arrange in due time to issue them with visas (passport details, flight number, place of departure and date of arrival).
- 12. Upon registration at the hotel Mabú Thermas & Resorts in Brazil, the Argentine authorities will hand over to participants a laissez-passer to cross the different borders.

V. AIR TRANSPORT AND RECEPTION

- 13. Argentina and Brazil are negotiating special air transport fares for participants. Detailed information concerning discounts provided by airlines will be shortly communicated in another Information Note.
- 14. Participants will be met either at the airport of Puerto Iguazú (Argentina), or at the airport of Foz de Iguaçu (Brazil) by a reception service set up by the Ministries of Tourism of the respective countries, which will help them to complete the formalities for entering their territory and provide transport from the airports to the hotels upon arrival and departure. Signs will be placed at several prominent places in the airports.
- 15. To enable the local authorities to organize this service, participants are requested to complete and return the attached participation form indicating their arrival, departure and accommodation details.
- 16. A shuttle service will also be scheduled for the registration of participants, the working sessions and the social events in the three countries of the Iguazú zone.

VI. ACCOMMODATION

17. Special rates, taxes not included, have been obtained for the following hotels in Brazil. Participants in the meeting are requested to make the reservation directly with the hotel, indicating their condition of participant of the WTO Conference.

XII. PRACTICAL INFORMATION

- Local currency and rate of exchange:
 - Argentina's official currency is the peso (ARS). The rate of exchange applicable in April 2005 is 2, 89 ARS to 1 US dollar.
 - Brazil's official currency is the real. The rate of exchange applicable in April 2005 is approximately 2,710 reals to 1 US dollar.
 - Paraguay's official currency is the guarani (PYG). The rate of exchange in April 2005 is 6,28 Guarani for 1 US dollar.
- Climate: The average temperature in this area is 25° C.
- Official language: Portuguese is the official language of Brazil, and Spanish is the official language of Argentina and Paraguay
- **Clothing:** Light and casual clothing is recommended. For meetings, women generally wear normal business attire and men a jacket and tie.
- Local time: GMT 3 in Argentina and Brazil; and GMT 2 in Paraguay.
- **Electricity**: The electric current in the three countries is 220 volts.
